
SUBJECT: California Senior Legislature Contract with California Department of Aging

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Authorize the Chairman of the Board to execute California Senior Legislature Contract for period January 1, 2006 through June 30, 2006 with the California Department of Aging (CDA).
- 2) Direct the Auditor-Controller to increase Estimated Revenue and Appropriations by \$2972 as outlined in Attachment "A".
- 3) Direct the Clerk of the Board to retain one original copy and return five (5) original copies of the contract to the Office on Aging for further processing.

BACKGROUND: On a bi-annual basis the Office on Aging Advisory Council on Aging conducts a process to recruit, interview and appoint the Riverside County Representative to the California Senior Legislature. California Department on Aging provides \$2972 to help defray the costs to the elections process. The funds will be used to cover materials and advertising costs. The elections must be completed by April 30, 2006.

There are no additional matching requirements and no impact to the county general fund..
