**RECOMMENDED MOTION:** That the Board of Commissioners:

1. Conduct a public hearing soliciting comments and objections to the proposed acquisition of real property in the unincorporated community of Glen Avon; and
2. Adopt Resolution Number 2006-03 declaring the intent of the Housing Authority to acquire real property located in the unincorporated community of Glen Avon from the Redevelopment Agency for the County of Riverside.

Departmental Concurrence

**BACKGROUND:** The Housing Authority proposes to acquire two (2) parcels located in the unincorporated community of Glen Avon between Bellegrave Avenue and 48<sup>th</sup> Street and east of Martin Street for the purpose of constructing two (2) single family homes. The Housing Authority intends to make these homes available as homeownership opportunities to low-income, first-time home buyers who are currently receiving tenant-based assistance from the Housing Authority. Project funding will be provided by the Low- and Moderate-Income Housing Fund of the Redevelopment Agency.

10 Authority intends to acquire certain real property located in the unincorporated  
11 community of Glen Avon between Bellegrave Avenue and 48<sup>th</sup> Street and east of Martin  
12 Street referenced within Assessor Parcel Numbers 159-061-004 and 159-061-006 to  
13 facilitate affordable homeownership opportunities.

14 NOTICE IS HEREBY GIVEN that the Board of Commissioners finds and determines  
15 the Housing Authority is authorized to acquire the above referenced property per  
16 Section 34312(a) of the California Health and Safety Code for the benefit of affordable  
17 housing to low-income persons. The Housing Authority proposes the acquisition of  
18 the above referenced property upon the following terms and conditions:

- 19           1. The seller of the subject property is the Redevelopment Agency for the  
20           County of Riverside;
- 21           2. The sales price of the property is \$1.00; and
- 22           3. The Redevelopment Agency for the County of Riverside is providing grant  
23           funding for development financing.

24 The property conveyance agreement shall be considered by the Board of  
25 Commissioners of the Housing Authority of the County of Riverside at a duly  
26 scheduled meeting in the meeting room of the Board of Supervisors, County
