**BACKGROUND:** This agreement between the State of California, Department of Forestry and Fire Protection and the County of Riverside provides for fire protection and emergency services within the area of responsibility of Riverside County. The initial term of this contract began on July 1, 2005, for three years. The Exhibit "E", Schedule "A" sets forth the expenditures contemplated by the agreement for the period of July 1, 2005 through June 30, 2008 which are not to exceed \$108,563,125 for FY 2005/06.
