**SUBJECT:** Amendment # 1 to Agreement # SD2215-00 05/06 with the Foundation for California State University, San Bernardino

**BACKGROUND:**

The Department of Public Social Services (DPSS) has entered into an agreement with the Foundation for California State University, San Bernardino to provide induction training to Children Services Social Services Workers. The course provides standardized Child Welfare Core Training.

The Foundation for California State University, San Bernardino has been under contract with the State of California since 1998 to provide initial and advanced training to the staff of the five southern California Public Child Welfare Services agencies.

The original agreement with the Foundation was for one course of thirteen (13) classes for thirty one (31) Social Services Workers. This amendment adds a second course of classes.

DPSS negotiated the agreement with the Foundation without competition in accordance with California Department of Social Services (CDSS) manual section 23-650, paragraph 1.14, which states that contracts may be negotiated without formal advertising "for any service to be rendered by any federal, state or local governmental agency, public university, public college or other public educational institution."
