**BACKGROUND:**

The District is funding all construction and inspection costs. Upon completion of project construction, the District will assume ownership, operation and maintenance of the mainline storm drains and major laterals.

The City is granting the District the necessary rights to construct, operate and maintain the project with City road rights of way and, upon completion of project construction, will assume ownership, operation and maintenance of the project's associated minor laterals located within City rights of way.

County Counsel has approved the Agreement as to legal form and the City has executed the Agreement.
