**SUBJECT: HOUSING AND URBAN DEVELOPMENT RENEWAL GRANT AGREEMENT—
 OPERATION SAFEHOUSE**

RECOMMENDED MOTION: That the Board of Supervisors approves and:

1. Authorizes the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for the Operation SafeHouse Main Street Transitional Living Project Supportive Housing Program (SHP) Grant for \$135,756 for the period of March 1, 2006 through February 28, 2007.
2. Authorizes the Chairman of the Board to sign the attached contract between DPSS and Operation SafeHouse;
3. Authorizes the Purchasing Agent to sign any ministerial amendments with Operation SafeHouse, not to exceed the maximum amount of the Grant Agreement \$135,756; and
4. Authorizes the Director of DPSS to administer the agreement with Operation SafeHouse.

BACKGROUND:

On July 13, 2004, (Agenda Item 3.37), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included the Main Street Transitional Living Program renewal project operated through a contract between Operation SafeHouse and DPSS to provide transitional housing and supportive services to 18-21 year old homeless youth in the Riverside area.

While the original project ended on February 28, 2006, HUD executed the attached renewal grant agreement on May 5, 2006. DPSS received this grant agreement on May 8, 2006. This renewal grant is retroactive because of staffing shortages in the Los Angeles HUD Field Office.

During the original project, Operation SafeHouse provided services to 49 participants. The goal under this renewal project is to serve the same number of participants.

FINANCIAL DATA: No County General Funds are required.
