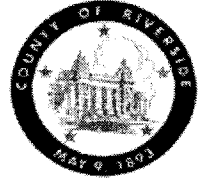

**SUBJECT:** Notice of Completion – Construction of Traffic Signal and Lighting Modifications, Van Buren Boulevard at Bellegrave Avenue, West Riverside area

**RECOMMENDED MOTION:** That the Board execute and file the attached “Notice of Completion”

**BACKGROUND:** By Minute Order 3.17 of April 12, 2005, the Board entered into an agreement with Hillcrest Contracting for the traffic signal and lighting modifications at the intersection of Van Buren Boulevard and Bellegrave Avenue in the West Riverside area of Riverside County. The authorized amount of the contract was \$460,079.00. The total amended contract amount (including Change Orders and quantity adjustments) is \$495,929.64, which is 7.8% more than the originally authorized amount.

This work was completed in conformance with the plans and specifications on January 3, 2006. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order B2-0413

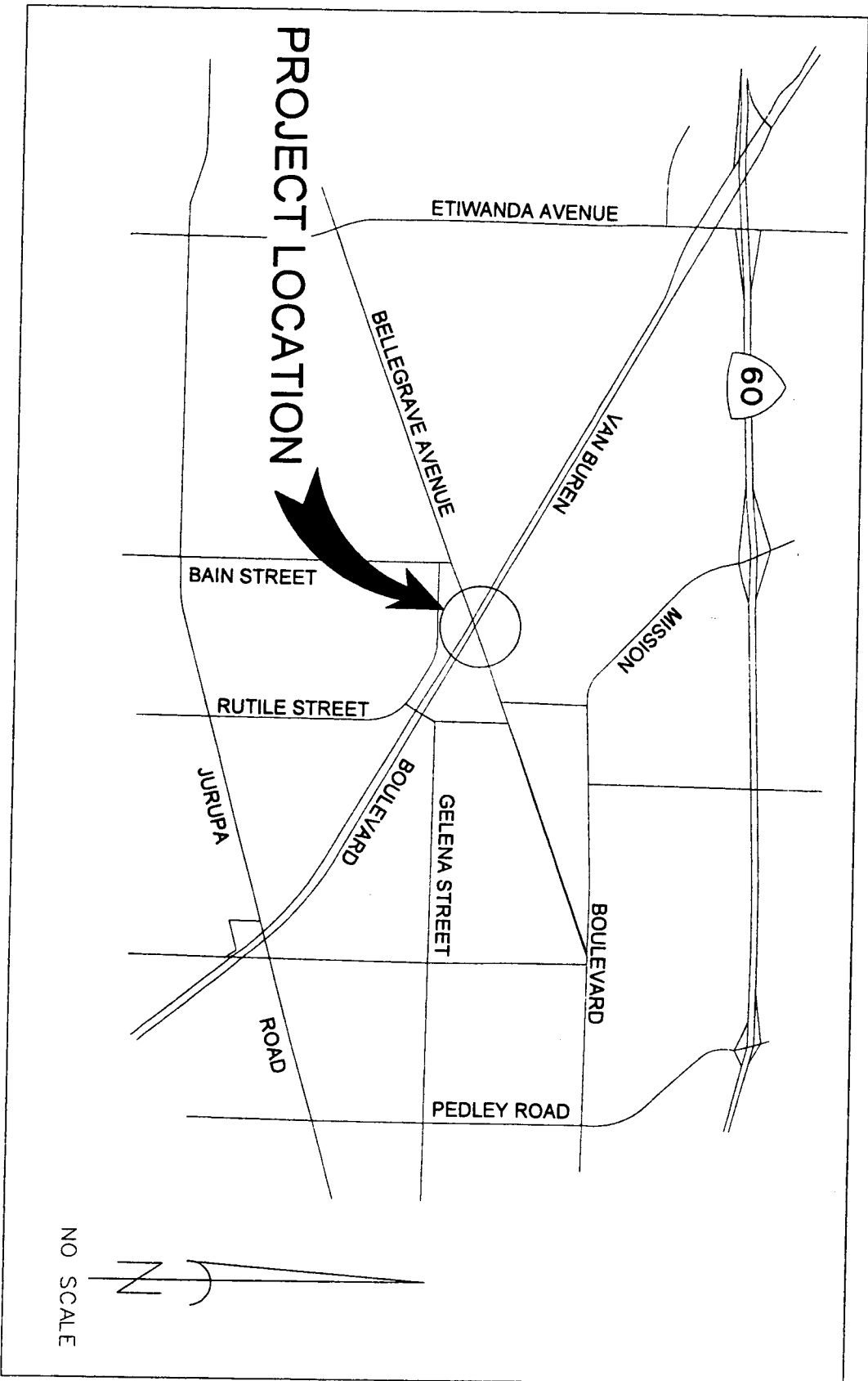
