**SUBJECT:** Acceptance of the FY 2005-06 Spousal Abuser Prosecution Program Agreement from the California Department of Justice

**RECOMMENDED MOTION:** That the Board of Supervisors approve acceptance of the Spousal Abuser Prosecution Program Grant award from the California Department of Justice for the grant period July 1, 2005 through June 30, 2006.

**BACKGROUND:** On October 7, 2003 (3.18) the Board of Supervisors adopted Resolution 2003-484 authorizing the District Attorney to submit renewal grant applications through FY2005-06 for the California Department of Justice Spousal Abuser Prosecution Program. The program, established by section 273.8 of the California Penal Code, is an ongoing vertical prosecution program that enhances the effort to prosecute and convict individuals arrested for spousal abuse crimes. The grant requires 20% in matching funds from the County of \$19,007. The matching funds and grant award of \$95,033 from DOJ result in a total project cost of \$114,040. Both the award amount and required County match are included in the department's current fiscal year budget.

The attached grant award has been reviewed and approved as to form by County Counsel.
