**BACKGROUND:** RCRMC surgeons require an experienced surgical blood recovery contractor with trained and experienced technicians for service and product support. Cardio Vascular Plus has been the contracted provider for this service, based on a request for proposal issued July 23, 2001, and approved by the Board on May 7, 2002, item number 3.37. This Amendment is to continue service at the same cost while RCRMC and County Purchasing completes the new Request for Proposal.
