**SUBJECT:** Introduction and Adoption of Ordinance No. 860 of the County of Riverside Establishing Fees of the Auditor-Controller

**RECOMMENDED MOTION:**

1. That the Board of Supervisors introduce and set for hearing adoption of Ordinance No. 860 of the County of Riverside pertaining to fees charged by the County Auditor-Controller; and,

**BACKGROUND:** Proposed Ordinance No. 860 will establish a single fee schedule for the County Auditor-Controller's Office by consolidating the fees currently contained in Ordinance Nos. 721 and 737, which are repealed by adoption of Ordinance No. 860. As highlighted in Attachment A, the new fee schedule updates and/or renames certain existing fees, adds certain new fees, and eliminates certain fees. None of these fees are payable by the general public.
