SUBJECT: Intent to Add Extended Public Safety, Park, and Landscape Maintenance Services to County Service Area 13

RECOMMENDED MOTION: That the Board of Supervisors:

1. Adopt Resolution No. 2006-244, Notice of Intent to Add Extended Public Safety, Park, and Landscape Maintenance Services within CSA 13 setting a public hearing for Aug. 15, 2006 to determine whether the extended service of sheriff, park, and landscape maintenance should be added to CSA 13; and
2. Direct the Clerk of the Board to publish a notice of the public hearing for Aug. 15, 2006 at 9:30 am.

BACKGROUND: County Service Area (CSA) 13 was formed on August 26, 1963, to provide street lighting in the North Palm Springs area. Increased residential development in the unincorporated area warrants the addition of services to include sheriff, park, and landscape maintenance to CSA 13. Pursuant to Government Code 25210.31, the Board of Supervisors may add extended types of services within an established county service area if determined to be a public convenience and necessity.

3 NOTICE OF INTENT TO ADD PUBLIC SAFETY,

6 **WHEREAS**, On August 26, 1963, the Board of Supervisors established County Service
7 Area No. 13 (CSA 13) in the unincorporated area of Riverside County encompassing the North
8 area of Palm Springs for the purpose of providing street lighting; and

9 **WHEREAS**, Government Code Section 25210.31 allows for adoption of a Resolution of
10 Intent to provide additional extended services within an existing County Service Area; and

11 **WHEREAS**, it has been requested that additional services to include sheriff, park, and
12 landscape maintenance be added to CSA 13;

15 **NOW, THEREFORE**, be it resolved by the Board of Supervisors of the County of
16 Riverside, State of California, in regular session assembled on July 11, 2006 that this Board
17 will conduct a public hearing on August 15, 2006 at 9:30 A.M. to determine whether
18 additional services to include sheriff, park and landscape maintenance should be added to CSA
19 13.

20 **BE IT FURTHER RESOLVED** that payment for such additional services ~~shall be~~
21 provided to County Service Area 13 shall be paid from service charges collected pursuant to
22 Government Code Section 25210.77a.

23 **BE IT FURTHER RESOLVED** that the Clerk of the Board is to give notice of the
24 proposed public hearing pursuant to Government Code 25210.33.
