**SUBJECT: HOUSING AND URBAN DEVELOPMENT RENEWAL GRANT AGREEMENT—
EPISCOPAL COMMUNITY SERVICES**

RECOMMENDED MOTION: That the Board of Supervisors approve and:

1. Authorize the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for the Episcopal Community Services Navajo Trails Supportive Housing Project Grant for \$231,420 for the period of July 1, 2006 through June 30, 2007;
2. Authorize the Chairman of the Board to sign the attached contract between DPSS and Episcopal Community Services;
3. Authorize the Purchasing Agent to sign any ministerial amendments with Episcopal Community Services not to exceed the maximum amount of the Grant Agreement \$231,420; and
4. Authorize the Director of DPSS to administer the agreement with Operation Episcopal Community Services.

BACKGROUND:

On July 7, 2005, (Agenda Item 3.60), your Honorable Board authorized DPSS to submit an application to the U.S. Department of Housing and Urban Development for Homeless Assistance funds, which included the Navajo Trails renewal project operated through a contract between Episcopal Community Services and DPSS to provide transitional housing and supportive services to persons with HIV/AIDS living in the Cathedral City area.

Episcopal Community Services has served 34 persons with HIV/AIDS under the current one-year grant which ends on June 30, 2006. HUD executed the attached renewal grant agreement on May 19, 2006, which we are forwarding to your Board for approval. Episcopal Community Services will continue its goal to serve 34 persons per year under the attached renewal grant.
