**BACKGROUND:**

On April 3, 2006, Riverside County Department of Public Social Services released Request for Proposal DPARC-015 for Anger Management/Domestic Violence Prevention.

The goal of Anger Management classes is to stop abusive and violent incidents of child abuse, teach alternative methods of expressing emotions, teach how to negotiate differences and hold the offender accountable for their behavior.

The goal of Domestic Violence Prevention is to modify the behavior of participating parents, particularly those who have been, or are at risk of, committing domestic violence, or have been identified by DPSS as already taking part in domestic violence. Treatment is designed to stop abusive or violent incidents, teach alternative methods of expressing emotions, learn how to negotiate differences and hold the offender accountable for their behavior.

The RFP closed on April 26, 2006 with proposals from six organizations.

After review of the proposals, two organizations were recommended to receive funding. Both agreements exceeded the Purchasing Agent's authority, and are being submitted to your Honorable Board for signature. The maximum amount for each agreement is as follows:

Family Services of the Desert	\$150,000
Olive Branch Counseling Center, Inc.	\$106,680

The above agreements will have two one-year renewal options with the same funding allocation.

Family Services of the Desert will provide services in the Eastern County, while Olive Branch Counseling Center will service the Western County.
