SUBJECT: Amendment to the agreement between Sourcecorp Healthserve and RCRMC.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the seventh amendment to the agreement between Sourcecorp Healthserve Radiology, Inc. and RCRMC for the performance period of July 1, 2006 through June 30, 2007;
- 2) Authorize the Chairman to execute the amendment;
- 3) Direct the Clerk of the Board to retain one (1) original and return two (2) original copies of the amendment to RCRMC.

BACKGROUND: The Board first approved the agreement with Sourcecorp Healthserve Radiology, Inc., on December 16, 1997 item number 3.15, the agreement was first amended by the Board July 20, 1999 item 3.23, a second amendment was approved May 15, 2001, item 3.23, a third amendment approved June 25, 2002, item 3.48, a fourth amendment approved February 24, 2004 item 3.31, fifth amendment approved September 14, 2004, item 3.49, and sixth amendment approved July 26, 2005, item 3.47. Sourcecorp Healthserve Radiology, Inc. provides RCRMC with the storage and retrieval of all hard copy Mammography films, and storage and retrieval of hard copy films prior to June 1998. In addition, hard copy files are converted into electronic images and provided on demand.

BACKGROUND (Continued): Also provided is the purging and destruction of stored films based upon statutory retention requirements and industry standards. Utilization is declining each year with a decrease in cost for storage and retrieval of films prior to the hospital's move. Storage and retrieval is required on all new mammography films.

JUSTIFICATION: This vendor is located within a thirty minute delivery time, and electronic images are available for recall of studies twenty four hours a day seven days a week

No other provider of this service is located within a delivery radius that would provide the level of service necessary to meet the needs of the Diagnostic Imaging Department at RCRMC.

PRICE REASONABLENESS: This Amendment is to renew Sourcecorp Healthserve's agreement for an additional year at the same vendor rates. The vendor certifies that prices offered are lowest, or equal to those offered to customers in San Bernardino or Riverside Counties.
