BACKGROUND: On October 19, 2004, the Board of Directors approved and executed a contract with Hillcrest Contracting Inc., for the construction of the Mission Boulevard, Phase IV Project. The Project included curb, gutter, sidewalk, block wall, wrought iron gates, landscape median, decorative parkway and street lighting between Riverview Drive and La Rue Street in Rubidoux. Construction of the Project has been completed within the Project budget, and formal acceptance of the street improvements is recommended.
