**SUBJECT:** Approval of Agreement with the California Department of Corrections and Rehabilitation for Juvenile Diagnostic Services.

**RECOMMENDED MOTION:** Approve the FY 06/07 Agreement with California Department of Corrections and Rehabilitation and Resolution No. 2006-278, which authorizes the Chairman to execute the agreement.

**BACKGROUND:** Section 1731.5 of the Welfare and Institutions Code provides for commitment of minors to the California Department of Corrections and Rehabilitation (CDCR), formerly California Youth Authority, when ordered by the Court. Approximately 160 youth from Riverside County are currently placed with the CDCR, and the County Probation Department is invoiced monthly for the cost of this care, based on a sliding scale related to the seriousness of the offense. A special category of placement is provided for in WIC 1731.6, which permits the Court to order certain minors into CDCR for a limited period of observation and diagnostic services, after which a report is made back to the Court. The attached agreement will allow for placement of up to seven minors per year for an average period of about 45 days each at a rate of \$6,690 per month. Funding for this agreement is included in the FY 2006-07 Probation Department budget.

The attached agreement has been approved as to form by the Office of the County Counsel.
