**SUBJECT: HOUSING AND URBAN DEVELOPMENT RENEWAL GRANT AGREEMENT—
VALLEY RESTART SHELTER**

RECOMMENDED MOTION: That the Board of Supervisors approves and:

1. Authorizes the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for the Valley Restart Stable Horizons Supportive Housing Program (SHP) Grant for \$120,932 for the period of March 1, 2006 through February 28, 2007.
2. Authorizes the Chairman of the Board to sign the attached contract between DPSS and Valley Restart Shelter;
3. Authorizes the Purchasing Agent to sign any ministerial amendments with Valley Restart Shelter, not to exceed the maximum amount of the Grant Agreement \$120,932; and
4. Authorizes the Director of DPSS to administer the agreement with Valley Restart Shelter.

AGREEMENT— VALLEY RESTART SHELTER

BACKGROUND:

On June 7, 2005, (Agenda Item 3.60), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included the Stable Horizons renewal project operated through a contract between Valley Restart Shelter and DPSS to provide supportive services to individuals living with dual-diagnosed disabilities.

While the original project ended on February 28, 2006, HUD executed the attached renewal grant agreement on May 9, 2006. DPSS received this grant agreement on May 15, 2006. Because of staffing shortages in the Los Angeles HUD Field Office, this agreement is being presented to the Board retroactively.

While the goal for this project is to serve 34 participants yearly, Valley Restart provided services to 39 participants during the past project year.

FINANCIAL DATA: No County General Funds are required.
