RECOMMENDED MOTION: That the Board ratify the cooperative agreements between the County of Riverside and the above subject School Districts regarding Adult School Crossing Guard Service within County of Riverside right-of-way and authorize the Chairman of the Board to execute these agreements on behalf of the County.

BACKGROUND: The County, through the Transportation Department, provides crossing guard services on a contract basis to several school Districts. This is a renewal of the Cooperative Agreement between the County and the above named School Districts for Adult School Crossing Guard Service for Fiscal Years 2006/07 and 2007/08. Based on the agreement, the school districts will pay 100% of the cost for crossing guard services and the Transportation Department will administer the program.
