BACKGROUND:

Pursuant to the Landscaping and Lighting Act of 1972 and Resolution 2006-193 adopted June 6, 2006, the Board of Supervisors noticed a public hearing for July 25, 2006, to receive testimony regarding the annexation of Zone 64 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated (L&LM Dist. No. 89-1-C). Annexation of Zone 64 will fund the maintenance and servicing of landscaping and catch basin filtration system improvements within public right-of-ways located northerly of Scott Rd.; easterly of Briggs Rd.; northerly and westerly of El Centro Ln.; in the Menifee area and includes 68 single-family residential lots.

On June 7, 2006, a notice of the public hearing and mail-in ballot, an impartial analysis, a copy of Resolution No. 2006-193 and an information sheet was mailed to all property owners within Zone 64 proposed for annexation to L&LM Dist. No. 89-1-C. Pursuant to the notice, all ballots must be returned prior to the conclusion of the public hearing.

Notice of the public hearing was also given by publication of a certified copy of Resolution No. 2006-193 in The Press Enterprise at least ten (10) days prior to the public hearing date and by posting a certified copy of the Resolution No. 2006-193 on the official bulletin board customarily used by the Board of Supervisors for the posting of notices and in two other public locations within the County.

Section 53753 of the Government Code has been amended. It requires that the Board after conducting the public hearing designate an impartial person, having no vested interest in the outcome of the proposed annexation, to tally the ballots received by the close of the public hearing at a specified time, date and place.
