SUBJECT: Recommendation for Distribution of Excess Proceeds for Tax Sale No. 170, Item 883.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the claim from County of Riverside, Assessment District 167 for payment of excess proceeds resulting from the Tax Collector's public auction sale associated with parcel 666392006-4;
- 2) Authorize and direct the Auditor-Controller to issue warrant to County of Riverside, Assessment District 167 in the amount of \$29,983.53, no sooner than ninety days from the date of this order, unless pursuant to the California Revenue and Taxation Code Section 4675, an appeal has been filed in Superior Court.

BACKGROUND: In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the March 15, 2004 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 20, 2004. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 9, 2004, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received one claim for excess proceeds:

- 1) Claim from County of Riverside, Assessment District 167 based on an Order Amending the Amended Judgment Entered October 30, 1998 recorded January 22, 2002 as Instrument No. 2002-036672.

Pursuant to Section 4675 (a) & (b) of the California Revenue and Taxation Code, it is the recommendation of this office that County of Riverside, Assessment District 167 be awarded excess proceeds in the amount of \$29,983.53.
