**SUBJECT: INDEPENDENT LIVING PROGRAM (ILP) — RIVERSIDE COMMUNITY COLLEGE DISTRICT**

**RECOMMENDED MOTION:** That the Board of Supervisors approves and:

1. Authorizes the Chairman of the Board to sign the attached Agreement between Riverside County Department of Public Social Services (DPSS) and Riverside Community College District for \$3,300,000 for the period of July 1, 2006 through June 30, 2009.
2. Authorizes the Purchasing Agent to sign any ministerial amendments with Riverside Community College District, not to exceed the maximum amount for each fiscal year of the Agreement (\$1,100,000); and
3. Authorizes the Director of DPSS to administer the Agreement with Riverside Community College District.

**SUBJECT:** INDEPENDENT LIVING PROGRAM (ILP)— RIVERSIDE  
COMMUNITY COLLEGE DISTRICT

**BACKGROUND:**

The Independent Living Program (ILP) was authorized by Public Law (P.L.) 99-272 in 1986, through the addition of section 477 to Title IV-E of the Social Security Act. The Act provided funds for programs to facilitate the preparation of Foster Care youth, ages 16 through 21, to acquire specific life skill competencies enabling youth to become independent adults.

This U.S. Department of Health and Human Services ILP Program supports the provision of services to help youth prepare for the transition from living within the child welfare system to living on their own as healthy, safe, and productive adults.

The Department of Public Social Services, Department of Probation, and Riverside Community College District have formed a collaborative relationship to operate the ILP to serve the youth in Riverside County, which we are submitting to your Board for approval.

On July 12, 2005, (Agenda Item #3.45) the Board approved a one-year agreement with the Riverside Community College District to provide Independent Living Skills and Emancipation services to youth who are or were wards or dependents of the Juvenile Court and in out-of-home care throughout Riverside County. This agreement, which DPSS negotiated with the Riverside Community College District under CDSS Regulation 23-650, expires on June 30, 2006. Although Riverside Community College proposed to subcontract with partners to provide ILP services to youth in the Eastern part of the County, RCC's staff will continue to commute to the region and provide these services until subcontracts have been negotiated. We are requesting this multi-year agreement to foster commitments from collaborative partners that would provide ILP services in the Eastern part of the County.

**FINANCIAL DATA:** 100% Federal Funds. No County General Funds are required.

Funding amount for the three (3) years is broken down as follows: Year 1- \$1,100,000; Year 2- \$1,100,000; and Year 3- \$1,100,000. The total agreement amount is \$3,300,000.
