**SUBJECT:** Addition of Public Safety, Park, and Landscape Maintenance Services within CSA 13, Public Hearing

**RECOMMENDED MOTION:** That the Board of Supervisors:

1. Conduct the public hearing for the project; and
2. Upon close of the Public Hearing, adopt Resolution No. 2006-245 Authorizing the Addition of Public Safety, Park, and Landscape Maintenance Services.

**BACKGROUND:** County Service Area (CSA) 13 was formed on August 26, 1963, to provide street lighting in the North Palm Springs area. Increased residential development in the unincorporated area warrants the addition of services to include sheriff, park, and landscape maintenance to CSA 13. Pursuant to Government Code 25210.31, the Board of Supervisors may add extended types of services within an established county service area if determined to be a public convenience and necessity. The adoption of Resolution No. 2006-245 will authorize CSA 13 to add extended services to include sheriff, park, and landscape maintenance.

7 **WHEREAS**, Government Code Section 25210.4 and 25210.31(a) authorizes the County  
8 to provide the extended governmental services within an established County Services Area; and

9 **WHEREAS**, it has been requested that additional services to include sheriff, park, and  
10 landscape maintenance be added to CSA 13; and

11 **WHEREAS**, a public hearing was conducted by this board on August 15, 2006 after  
12 which this Board determined that public convenience and necessity require that additional  
13 services to include sheriff, park, and landscape maintenance should be added to CSA 13.

15 **NOW, THEREFORE**, be it resolved by the Board of Supervisors of the County of  
16 Riverside, State of California, in regular session assembled on August 15, 2006 that the  
17 addition of services to include sheriff, park, and landscape maintenance should be added to CSA  
18 13.

19 **BE IT FURTHER RESOLVED** that such additional services to include sheriff, park,  
20 and landscape maintenance shall be provided locally within the geographical boundaries of CSA  
21 13, and that ~~such~~ payment for said additional services shall be made from ~~and~~ assessments  
22 collected pursuant to Section 25210.77 (a) of the Government Code.
