SUBJECT: Agreement between the City of Indio and County of Riverside for the Provision of Fire and Police Services and the Maintenance of Certain Roads in the Westside Annexation Area

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve the attached Agreement between the City of Indio and the County of Riverside for the Provision of Fire and Police Service and the Maintenance of Certain Roads in the Westside Annexation Area.
2. Authorize the Chairman to execute the agreement on behalf of the County.

BACKGROUND: On December 8, 2005, the Local Agency Formation Commission (LAFCO) approved the annexation of the Fiesta de Vida Development to the city of Indio. In its approval of the Fiesta de Vida annexation, LAFCO applied a condition to encourage the annexation of approximately 950 acres, referred to as the Westside Annexation Area, located immediately south of Fiesta de Vida. The attached agreement was prepared, consistent with the LAFCO condition, to require the city to provide police, fire and road maintenance to the Westside Annexation Area. The agreement will be terminated upon completion of or denial of the Westside Annexation Area application by LAFCO.

BACKGROUND CONTINUED:

The agreement provides for pavement upgrades of two roads in the Westside Annexation area. The pavement upgrades will occur within two years of the certificate of completion for the annexation of the Westside Annexation Area. The estimated cost of these upgrades is \$320,000 and will be funded using capital improvement funds dedicated for infrastructure improvements for the Bermuda Dunes area by the Palm Desert Redevelopment Agency.
