SUBJECT: 2006 California Department of Forestry and Fire Protection Volunteer Fire Assistance Grant Program

RECOMMENDED MOTION: That the Board of Supervisors:

1. Accept \$9,945 in grant funding awarded to Riverside County Fire Department (RCOFD) by the 2006 California Department of Forestry and Fire Protection (CDF) Volunteer Fire Assistance (VFA) Grant Program;
2. Authorize the Fire Chief to administer all actions necessary and to sign any related grant documents to implement the grant; and
3. Authorize the Auditor-Controller to make budget adjustments shown on Schedule A.

BACKGROUND: As a result of new fire service regulations related to personal protective equipment, RCOFD must purchase new fire shelters. The CDF VFA grant provides funding for rural areas to purchase this type of personal protective equipment. RCOFD was awarded \$9,945 in grant funding to purchase 78 fire shelters that will be stored and distributed by the following rural fire stations: Nuvview #3; Goodmeadow #9; Mecca #40; Thermal #39; and Valle Vista #72. The grant has a 50/50 cost share requirement as follows: 50% federal (\$9,945) and 50% non-federal (\$9,945) for a total budget of \$19,890. RCOFD's portion of the cost share is in the current year budget.
