3 RESOLUTION OF THE BOARD OF SUPERVISORS REMOVING AND ADDING APPLICANT
4 AGENTS FOR THE PURPOSE OF SECURING FEDERAL AND STATE FINANCIAL
5 ASSISTANCE FOR DISASTERS AND OTHER EMERGENCIES

6 BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of Riverside,
7 State of California, in regular session on August 29, 2006, that John R. Hawkins, by virtue of his
8 position as County Fire Chief, in accordance with Riverside County Ordinance 533.5 Section
9 7.2b, and Gail Barclay, Deputy Director Administration, by virtue of her responsibility for financial
10 recovery following a disaster, are hereby added to the County of Riverside list of applicant
11 agents, that is, those authorized to execute for and on behalf of the County of Riverside,
12 applications and documents as may be required by and filed with the State Office of Emergency
13 Services for the purpose of obtaining financial assistance under Public Law 93-288 as amended
14 by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, or state
15 financial assistance under the National Disaster Assistance Act. Craig E. Anthony and Brad
16 Harris are hereby removed from the list because they no longer hold positions that qualify them
17 as applicant agents. Larry Parrish, County Executive Officer and Mary Moreland, Deputy
18 Director Fire/OES, shall remain on the list of authorized applicant agents.
