**SUBJECT:** Bob Hope Drive/Ramon Road Interchange Freeway Agreement between the State of California, Department of Transportation and the County of Riverside.


**RECOMMENDED MOTION:** That the Board approve the attached Freeway Agreement between the State of California and the County of Riverside for the Bob Hope Drive/Ramon Road at Interstate 10 Interchange project and authorize the Chairman to execute the same.

**BACKGROUND:** Caltrans is the lead agency for the proposed new interchange located on Interstate 10. Construction of this new interchange will require a new connection to Interstate 10 between the Date Palm Drive Interchange and the Ramon Road Interchange and modifications to the existing Ramon Road Interchange.

This Freeway Agreement between the State of California and the County of Riverside will:

1. Supersede in its entirety the February 23, 1960 Freeway Agreement
2. Supersede the portion of the August 9, 1965 Freeway Agreement from 1.2 miles easterly of Date Palm Drive to one mile westerly of Ramon Road.
