SUBJECT: Formation of Wildomar Landscape Maintenance District 2006-1, Public Hearing.

RECOMMENDED MOTION: That the Board of Supervisors:

1. Conduct the public hearing on formation of the Wildomar Landscape Maintenance District 2006-1;
2. Upon close of the public hearing, direct the Executive Director of the Economic Development Agency or designee, who the Board finds to be an impartial person as that term is used in Section 53753(e) of the Government Code, to tally all ballots received prior to the close of the public hearing. All ballots received prior to the close of the public hearing will be tallied at 10:00 a.m. on Wednesday, August 30, 2006 at the office of EDA Administration, 1157 Spruce St, Riverside, CA 92507; and
3. Direct staff to cause the appropriate resolution, based on the election tally, to be prepared and returned to the Board for its consideration.

Pursuant to the Landscaping and Lighting Act of 1972 and Resolution 2006-262 adopted July 11, 2006, the Board of Supervisors noticed a public hearing for August 29, 2006, to receive testimony regarding the formation of Wildomar Landscape Maintenance District 2006-1 (Wildomar LMD 2006-1). Formation of Wildomar LMD 2006-1 will fund the maintenance and servicing of landscaping for public parks located within the boundaries of Wildomar LMD 2006-1 as shown in Exhibit "A." Specifically Marna O'Brien Park, Heritage Park, Windsong Park, and a new ten (10) acre park to be named Wildomar Park East.

On July 12, 2006, a mail-in ballot and a copy of Resolution No. 2006-262 (notice of public hearing) was mailed to all property owners within Wildomar LMD 2006-1. Pursuant to the notice, all ballots must be returned prior to the conclusion of the public hearing.

Notice of the public hearing was also given by publication of a certified copy of Resolution No. 2006-262 in The Press Enterprise at least ten (10) days prior to the public hearing date and by posting a certified copy of the Resolution No. 2006-262 on the official bulletin board customarily used by the Board of Supervisors for the posting of notices and in two other public locations within the County.

Section 53753 of the Government Code has been amended. It requires that the Board designate an impartial person after conducting the public hearing, having no vested interest in the outcome of the proposed annexation, to tally the ballots received by the close of the public hearing at a specified time, date and place.

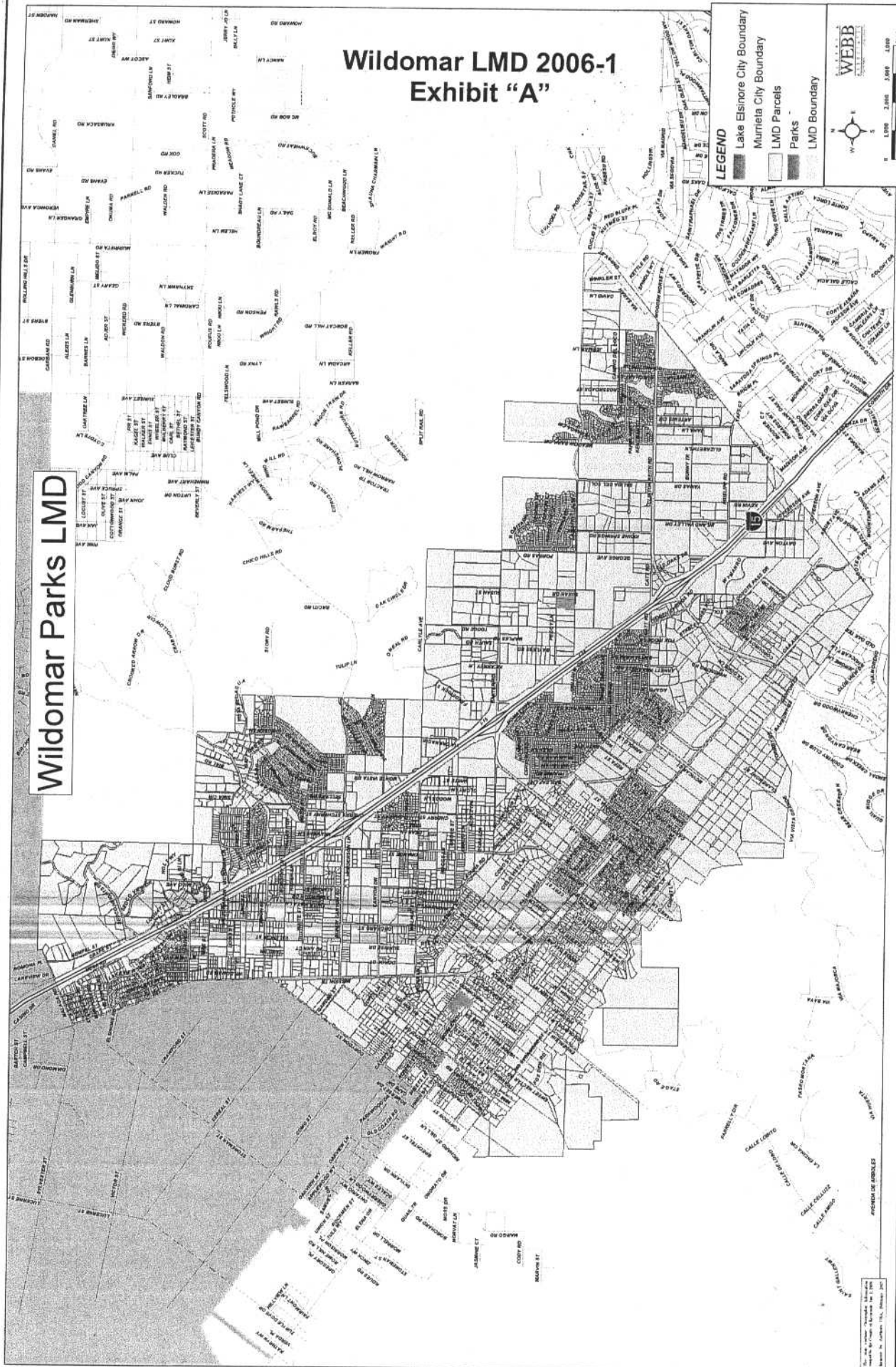
Wildomar Parks LMD
