**RECOMMENDED MOTION:** That the Board of Supervisors approve and:

1. Authorize the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for the City of Riverside's Street Outreach Project Supportive Housing Program (SHP) Grant for \$722,904 for the period of three years after the start of supportive services;
2. Authorize the Chairman of the Board to sign the attached contract between DPSS and the City of Riverside;
3. Authorize the Purchasing Agent to sign any ministerial amendments with the City of Riverside, not to exceed the maximum amount of the Grant Agreement (\$722,904); and
4. Authorize the Director of DPSS to administer the agreement with the City of Riverside.

**BACKGROUND:**

On July 13, 2004, (Agenda Item 3.37), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development that included the Street Outreach Program which will be operated through a contract between the City of Riverside and DPSS. Under this program the City of Riverside will provide supportive services to chronically homeless individuals with mental illness in the Riverside area.

The City of Riverside's project goal is to reach 1,000 homeless individuals over the three-year term of the grant.
