**SUBJECT:** Contract Agreement with San Diego State University Foundation, School of Social Work to provide consulting services to DPSS Directors.

**BACKGROUND:**

This Contract is between DPSS and San Diego State University (SDSU) Foundation, School of Social Work on behalf of the Academy for Professional Excellence for the Southern Area Consortium of Human Services (SACHS). The Consortium was established during FY 2001/2002, and is made up of two universities (SDSU and CSU-San Bernardino), eight counties (Imperial, Los Angeles, Orange, Riverside, San Bernardino, Santa Barbara, and Ventura), and one foundation (SDSU Foundation).

The Southern Area Consortium of Human Services (SACHS), a county/university partnership, will engage in strategic planning; training; policy development; advocacy; and research to improve the quality and responsiveness of human services in the Southern California region.

SACHS will be a forum for County Directors to explore and exchange ideas and information on issues facing public human services to develop strategies for addressing these issues.

SACHS is tailored to regional needs and issues. SACHS also acts as a clearinghouse for current research and information on pertinent issues.

Each participating county contributes a proportionate amount to cover the operating expenses for SACHS.

DPSS negotiated the agreement with the Foundation without competition in accordance with California Department of Social Services (CDSS) manual section 23-650, paragraph 1.14, which states that contracts may be negotiated without formal advertising "for any service to be rendered by any federal, state or local governmental agency, public university, public college or other public educational institution."
