BACKGROUND:

On May 2, 2006, the Board of Supervisors approved Agenda Item 3.29, authorizing DPSS-CAP Riverside to administer the Southeast Asian People's Farm Project for the term of February 1, 2006 through July 30, 2006. Amendment #1 would extend the end of the term of the agreement from July 30, 2006 to August 25, 2006 to allow for final expenditure of previously approved activities.

Therefore, the Executive Director of DPSS-CAP Riverside requests the Board to approve Amendment #1 to the Funding Agreement/Letter of Agreement between CAL/NEVA and DPSS-CAP Riverside extending the end of the term of the agreement to August 25, 2006.
