SUBJECT: Ratify the contract with Inland Empire Health Plan (IEHP) to add participation in the IEHP Direct Plan

RECOMMENDED MOTION: That the Board of Supervisors: 1) Ratify the contract between Community Health Agency (CHA), Department of Public Health and IEHP for the period of May 1, 2006 through April 30, 2011 with an estimated revenue of \$300,000 annually; 2) Authorize the Chairperson to execute four (4) copies of the contract; and 3) Direct the Clerk of the Board to return three (3) executed documents to the Department of Public Health Contracts Administration for final processing.

BACKGROUND: Community Health Agency currently has a contract with IEHP to provide primary care to IEHP members who are assigned to any of the nine County Family Care Centers. However, the current IEHP members are assigned to the County Clinics through two IPAs (Independent Practice Associations): Mission and Vantage. IEHP has begun contracting directly with providers, thereby eliminating the use of IPAs. This new contract will allow IEHP to assign members to the nine DOPH Family Care Centers without going through either of the current IPAs. By adding IEHP Direct, the Riverside County Family Care Centers will possibly gain additional enrollment, and increased reimbursement for services provided to those members/patients. The estimated increase in revenue of \$300,000 is Included in the FY 06/07 CHA Budget. Clinic Management has to review and approve the content of the contract and has delayed the submission of this Form 11.
