SUBJECT: Amendment 1 State Standard Agreement 05-06-1

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the first (1st) amendment to the State Standard Agreement 05-06-1 with the Department of Corrections and Rehabilitation-Division of Juvenile Justice to provide medical services to the wards assigned to the Department of Youth Authority-Chino, CA, effective July 1, 2006 through June 30, 2007; and
- 2) Authorize the Chairperson to execute three (3) copies of the amendments; and
- 3) Direct the Clerk of the Board to return all three (3) copies of the signed originals to Riverside County Regional Medical Center Administration. Upon final approval, a fully executed Amendment will be returned to the Clerk of the Board.

BACKGROUND: On October 18, 2005, Agenda Item No. 3.45, the Board of Supervisors approved the agreement with the State of California Department of Corrections and Rehabilitation-Division of Juvenile Justice to provide medical and emergency services to the wards assigned to the Department of Youth Authority-Chino, CA.

The State of California Department of Corrections and Rehabilitation-Division of Juvenile Justice has exercised their option to renew the Agreement with RCRMC for an additional year for the period of July 1, 2006 through June 30, 2007.
