SUBJECT: Seventh (7th) Amendment to the Professional Medical Services Agreement between the County of Riverside and Riverside Regional Pediatric Medical Group, Inc.

RECOMMENDED MOTION: 1) Ratify the amendment to the Professional Medical Services Agreement, effective October 1, 2006; 2) authorize the Chairperson to sign three (3) copies of the amendment; 3) Retain one (1) copy and return two (2) copies of the executed amendment to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: On August 10, 1999, Agenda Item No. 3.56 the Board of Supervisors approved a contract with Riverside Regional Pediatric Medical Group, effective August 15, 1999, to provide Pediatric Specialty Care Professional services. The Agreement was first amended on July 10, 2001, agenda item no. 3.49 to increase pediatric sub-specialty services. A second (2nd), third (3rd) and fourth (4th) amendment were approved on March 12, 2002 agenda item no. 3.43, May 7, 2002, agenda item no. 3.38 and October 1, 2002, agenda item no. 3.25 adding neonatology professional services and revising language to comply with regulatory requirements.

BACKGROUND (Continued):

A fifth (5th) and sixth (6th) amendment were approved on December 10, 2002, agenda no. 3.38 and June 17, 2003, agenda no. 3.27 adding neonatology nurse practitioner services for twenty-four (24) hour coverage of the hospital's neonatal intensive care unit (NICU) and revising the maximum annual compensation for the agreement.

This seventh (7th) amendment to the Riverside Regional Pediatric Medical Group modifies the pediatric sub-specialty services required as part of the groups responsibility and adjusts the compensation for these reduced services.

This Amendment has been approved as to form by County Counsel.
