SUBJECT: Ratify the Agreement for the acceptance of funding for the Riverside County Friday Night Live Southern Regional Teen Leadership training and conference for FY 2006/2007.

RECOMMENDED MOTION: Move that the Board of Supervisors:

1. Ratify the Agreement between the Riverside County Department of Mental Health/Riverside Friday Night Live Partnership and Tulare County Office of Education/California Friday Night Live Partnership (CFNLP) for a maximum amount of \$20,000 to fund the Southern Regional Teen Leadership training and conference for FY 2006/2007; and
2. Authorize the Chairman of the Board of Supervisors to sign the agreement.

BACKGROUND:

As part of the Department of Mental Health's Friday Night Live program mission to develop and support substance abuse prevention programs, the Department of Mental Health's Friday Night Live program hosted a two-day Southern Regional Teen Leadership training and conference on October 13-15, 2006 at Chai Mountain conference facility.

SUBJECT: Ratify the Agreement for the acceptance of funding for the Riverside County Friday Night Live Southern Regional Teen Leadership training and conference for FY 2006/2007.

BACKGROUND (cont'd):

The leadership training and conference is an occasion for information dissemination, sharing of knowledge, and promotion of constructive and healthy alternatives to alcohol, tobacco and other drug use. This leadership training and conference is an opportunity to convene a group of youth, school administrators, educators, law enforcement officials, county alcohol and drug administrators and community members that are representative of the region who are leaders in the planning, implementation and evaluation of Friday Night Live projects throughout the Southern region of California. The leadership training and conference's theme is "Chapter 2... Making It Happen"; which demonstrates the organizers and participants' desire to follow through with the alcohol and prevention strategies they have learned throughout the years and to put those strategies and practices into play. The funding agreement outlines the following goals and objectives for the Southern Regional Teen Leadership training and conference: 1) A minimum of eight hours of training for the regional youth leaders; 2) Provide youth training on multiple strategies for implementation of environmental prevention projects, planning and implementation of prevention strategies, policy advocacy, mentoring and other youth identified topics; 3) Provide aspects of support necessary to implement other leadership trainings; and 4) Create partnerships that will enhance leadership training and support the ongoing opportunities for youth participants.

The Southern Regional Teen Leadership training and conference is funded by the California Department of Alcohol and Drug Programs (ADP), via an agreement between Riverside County Department of Mental Health (Riverside Friday Night Live Partnership) and the Tulare County Office of Education. The funding will be used to offset county costs for the Southern Regional Teen Leadership training and conference; and will assist the county in paying for presenters and handling travel accommodations for out of county participants.

JUSTIFICATION FOR DELAY

The Southern Regional Teen Leadership training and conference was already in the implementation phase when the Riverside County Department of Mental Health/Riverside Friday Night Live Partnership became aware of the funding that would become available on October 1, 2006. The agreement was prepared by the Tulare County Office of Education on behalf of the California Department of Alcohol and Drug Programs/California Friday night Live Collaborative and received by the Riverside County Friday Night Live Program on October 4, 2006.

PERFORMANCE PERIOD

The grant period funding for these services is October 1, 2006 thru September 30, 2007. However, services will be completed within the Riverside County Department of Mental Health's FY 2006/2007. No additional county funds are required.
