BACKGROUND: (Continued).

Riverside County Department of Public Health Disease Control Branch is collaborating with Valley Health System on the Healthy Children Connection project. The program promotes early entry into prenatal care and timely immunizations of children five years of age and under. Valley Health System offers services to clients in Districts 1, 3, and 5 with funding through First 5 Riverside in the amount of \$200,700 for FY 05/06 and \$100,350 for FY 06/07.

Although the Riverside County Department of Public Health is the lead Agency, collaborative partners are needed to ensure effective implementation of the program at a local level. Exhibits A and Attachment A have been modified, and Attachment D has been added for the period of January 1, 2006 – December 31, 2006 to reflect changes to the Scope of Work at the request of First 5 Riverside.
