SUBJECT: Joint Exercise of Powers Agreement Between Jurupa Community Services District and the County of Riverside Regarding Landscape Maintenance within Community Facilities Districts Nos. 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 23, 24, 25, 26, 27, 28, 30, 32 and 34 ("CFD Nos. 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 23, 24, 25, 26, 27, 28, 30, 32 and 34") of Jurupa Community Services District.

RECOMMENDED MOTION: That the Board of Supervisors approve and authorize the Chairman to execute the attached Joint Exercise Powers Agreement Between the Jurupa Community Services District and the County of Riverside Regarding Landscape Maintenance.

BACKGROUND: The County of Riverside ("County") and Jurupa Community Services District ("District") entered into an agreement entitled "Joint Exercise Powers Agreement Between the Jurupa Community Services District and the County of Riverside Regarding Landscape Maintenance, dated July 1, 2000. By that agreement the District and County agreed that District, as County's agent, will maintain street trees and landscape located in the rights-of-way of public roads and streets within the District's Community Facilities District No. 2 (Eastvale area); and entered into an agreement entitled "Joint Exercise Powers Agreement Between the Jurupa Community Services District and the County of Riverside Regarding Landscape Maintenance, dated March 16, 2004. By that agreement the District and County agreed that District, as County's agent, will maintain street trees and landscape located in the rights-of-way of public roads and streets within District's Community Facilities District Nos. 3, 4, 5, 6, 7, 8, 9 and 10 (Eastvale area).

The District, as County's agent, will maintain the street trees and landscape with funds provided from the levy of special taxes on parcels of taxable property within the area of each of the District's CFD Nos. 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 23, 24, 25, 26, 27, 28, 30, 32 and 34 (Eastvale area). The attached agreement outlines the terms of participation by the District and the County.
