SUBJECT: Approval of Memorandum of Understanding between the County of Riverside and the Judicial Council of California, Administrative Office of the Courts for Continued Use of the Historic 1903/1933 County Courthouse under the Trial Court Facilities Act of 2002 (SB1732)

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the Memorandum of Understanding between the County of Riverside and the Judicial Council of California, Administrative Office of the Courts and authorize the Chairman to sign; and,
- 2) Direct the Executive Office to proceed with any necessary actions to effect this transaction.

BACKGROUND: The Trial Court Facilities Act of 2002, SB1732, was enacted to provide for the transfer of responsibility for funding and operation of trial court facilities from the counties to the Judicial Council of California (JDC). SB1732 provides an exception to such transfers for historic facilities. Because the county wishes to retain title to the Historic Courthouse, a Memorandum of Understanding (MOU) between the JDC and the county allows the Superior Court to continue using the facility as a working court facility. No transfer of responsibility or ownership occurs with the passage of this MOU. The county will retain title, responsibility for funding and operation of the Historic Courthouse, and no payments are required to be paid to the state for this facility as long as it remains a working court facility. If for some reason the county requires the movement of the Superior Court out of the Historic Courthouse building, the county will then be required to make payments to the state for operation of a new court facility. This MOU has been reviewed by the Riverside County Superior Court executive staff and Facilities Management.
