SUBJECT: Approve the First 5 Riverside Agreement 07-9336 OP between Riverside County Children and Families Commission and the Department of Public Health, Community Health Agency Nutrition Services Branch.

BACKGROUND: Riverside County Community Health Agency Department of Public Health Nutrition Services Branch received six months continued funding from Riverside County Children and Families Commission (RCCFC) in the amount of \$171,112. With these funds the Nutri-Steps/Healthy You and Me program will:

- a) Conduct nutrition and physical activity education classes for children, parents, and childcare providers countywide.
- b) Educate childcare providers on ways to implement six obesity prevention activities as part of their curriculum.
