SUBJECT: Approve the First 5 Riverside Agreement 07-21 OP between Riverside County Children and Families Commission and the Department of Public Health, Community Health Agency Nutrition Services Branch.

BACKGROUND: Riverside County Community Health Agency Department of Public Health Nutrition Services Branch received six months continued funding from Riverside County Children and Families Commission (RCCFC) in the amount of \$309,116. During these six months of funding, Nutrition Services' Loving Support Breastfeeding program will:

- a) Operate a 24-hour, seven days per week breastfeeding support helpline for pregnant and postpartum mothers.
- b) Provide education and training to OB/GYN or Pediatric physicians to complete the seven steps required to receive a breastfeeding friendly office designation.
- c) Support newly postpartum mothers with breastfeeding materials and counseling support through the 24 hour breastfeeding help line.
