SUBJECT: Approval of a Memorandum of Understanding with the County Office of Education for the Sheriff's Provision of a Lieutenant to Act as a School Liaison Officer

RECOMMENDED MOTION: Move that the Board of Supervisors approve and authorize the Sheriff to sign a three-year Memorandum of Understanding (MOU) between the County and the Riverside County Office of Education.

BACKGROUND: On November 21, 2001, the Board approved the creation of a new position, the School Liaison Officer/Lieutenant. This position, working through the County Office of Education (COE), oversees the daily activities of the Sheriff's Department's 50 School Resource Officer Deputies. Additionally, the position works with each school district to develop Safe School Plans and assists with the development and implementation of programs to help families redirect youth who may be truant, incorrigible or even first-time offenders.

Since June 2002, COE has agreed, as part of an MOU, to pay for 1/2 the cost of a Sheriff's Lieutenant to fulfill the duties briefly described above. On June 5, 2006, COE signed and reconfirmed its understanding of the Sheriff's provision of a School Liaison Officer for a new term to extend through June 30, 2009. County Counsel has approved the MOU as to form.
