SUBJECT: 2007-2009 Riverside County Fair & National Date Festival Carnival Provider

RECOMMENDED MOTION: That the Board of Supervisors approve and authorize the Chairman to execute the attached contract between Butler Amusements and the Riverside County Fair & National Date Festival.

BACKGROUND: On October 23, 2006, the Riverside County Fair & National Date Festival Fairgrounds released a Carnival Operator Request For Proposal Package, inviting Bids from all interested parties in providing carnival operations for the Fair. The final bid close date was on November 27, 2006. Four bid responses were submitted. An Evaluation Committee reviewed the bid responses, and Butler Amusements received the highest score. After bidders were notified of the Agency's intent to recommend awarding the contract to Butler Amusements, two bidders submitted letters contesting the decision. Staff has reviewed and found their response lacking specific justification to alter the scores assigned each bidder. Therefore, staff recommends the Board award Butler Amusements the contract due to their superior bid.

The contract has been reviewed and approved as to form by County Counsel.
