RECOMMENDED MOTION: That the Board of Supervisors:

1. Authorize the Chairman of the Board to sign the attached Agreement #07F-4816 between the Department of Community Services and Development (CSD) and the Department of Public Social Services-Community Action Partnership of Riverside County (DPSS-CAP Riverside) for a maximum agreement amount of \$75,000 covering the term November 1, 2006 through June 30, 2007;
2. Instruct the Auditor Controller to adjust the DPSS-CAP Riverside budget as follows:

RECOMMENDED MOTION (Cont.):

3. Authorize the Purchasing Agent to sign future amendments on behalf of the County not to exceed the Board approved allocation; and
4. Authorize the Executive Director of DPSS-CAP Riverside to sign assurances, exhibits, and reports made under the Agreement.

BACKGROUND:

In 2003, CSD provided \$45,000 in Community Services Block Grant (CSBG) Discretionary funds to DPSS-CAP Riverside to supply relief to those residents who were impacted by the October and November wildfires. DPSS-CAP Riverside distributed air purifiers, personal emergency first aid/safety kits, vouchers to department and grocery stores and provided shelter/rental assistance.

CSD has again authorized CSBG Discretionary funding to DPSS-CAP Riverside. Agreement #07F-4816 would provide \$75,000 in funding to supply relief to those residents impacted by the Esperanza and Lookout Fires. DPSS-CAP Riverside will distribute air purifiers, vouchers to department and grocery stores, and will provide utility bill payment assistance and shelter/rental assistance.

Therefore, the Executive Director of DPSS-CAP Riverside requests the Board to approve Agreement #07F-4816 not to exceed \$75,000, covering the term November 1, 2006 through June 30, 2007.

FINANCIAL IMPACT: No County General Funds will be required.
