SUBJECT: Notice of Completion – Storm Damage Repairs, Reconstruction of segments of Pauba Road, from Los Caballos Road to North of State Route 79 and Reconstruction of Storm Drain Channels in Temecula area.

RECOMMENDED MOTION: That the Board execute and file the attached "Notice of Completion"

BACKGROUND: By Minute Order 3.52 of July 25, 2006, the Board entered into an agreement with Grand Pacific Contractors, Inc. of Mira Loma, CA. for the reconstruction of segments of Pauba Road, from Los Caballos Road to North of State Route 79 and Storm Drain Channels in Temecula area of Riverside County. The authorized amount of the contract was \$565,400.00. The total amended contract amount (including quantity adjustments) is \$608,165.63, which is 7.6% more than the originally authorized amount.

This work was completed in conformance with the plans and specifications on November 15, 2006. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order 4505120104.
