BACKGROUND: By Minute Order 3.64 of September 26, 2006, the Board entered into an agreement with Grand Pacific Contractors for the reconstruction of a portion of Jenny Lane and Capano Bay Court, in Riverside County. The authorized amount of the contract was \$100,690.00. The total amended contract amount (including quantity adjustments) is \$96,768.28, which is 3.9% less than the originally authorized amount.

This work was completed in conformance with the plans and specifications on November 13, 2006. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order 4505120109.
