SUBJECT: Amendment to the Professional Services Agreement between the County of Riverside and Loma Linda University Healthcare

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the amendment with Loma Linda University Healthcare effective September 5, 2006; and
- 2) Authorize the Chairperson to execute three (3) copies of the agreement; and
- 3) Retain one (1) copy of the Loma Linda University Healthcare agreement and return two (2) copies of the executed agreements to Riverside County Regional Medical Center (RCRMC) administration for distribution.

BACKGROUND: On August 29, 2006, agenda item no. 3.67, an agreement was approved with Loma Linda University Healthcare for the provision of comprehensive general surgery professional services to the patients at RCRMC on an inpatient, outpatient and emergency basis. Loma Linda University Healthcare has provided professional surgical services to Riverside General Hospital (RGH) Riverside County Regional Medical Center (RCRMC) for over thirty-five years.

BACKGROUND (Continued):

This agreement has been amended to include Medical Director services for the Riverside County Regional Medical Center. The services that will be provided include establishing standards to ensure compliance with Joint Committee Accreditation of Healthcare Organizations (JCAHO), Title 22 regulations, and Centers for Medicare and Medicaid Services (CMS) requirements, along with the directing and coordination of medical staff policies and to provide leadership for the Hospital's medical staff.

All of the required services have been incorporated into the amendment that clearly outlines the duties, obligations and responsibilities of the Contractor.
