**SUBJECT:** Notice of Completion – Construction of Sidewalk, Curb and Gutter, and Road Improvements on Conning Street from Mission Boulevard to Ben Nevis Boulevard, Glen Avon area.

**RECOMMENDED MOTION:** That the Board execute and file the attached "Notice of Completion"

**BACKGROUND:** By Minute Order 3.68 of July 11, 2006, the Board entered into an agreement with Sully Miller Contracting Company of Anaheim, CA. for the construction of Sidewalk, Curb and Gutter, and Road Improvements on Conning Street from Mission Boulevard to Ben Nevis Boulevard, in the Glen Avon area of Riverside County. The authorized amount of the contract was \$474,000.00. The total amended contract amount (including quantity adjustments) is \$409,382.00, which is 13.6% less than the originally authorized amount.

This work was completed in conformance with the plans and specifications on November 24, 2006. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order B5-0551.

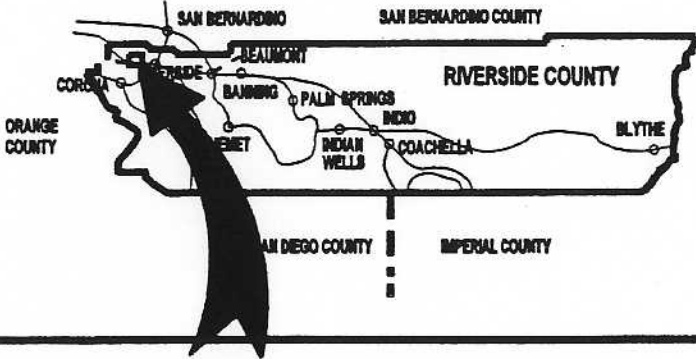

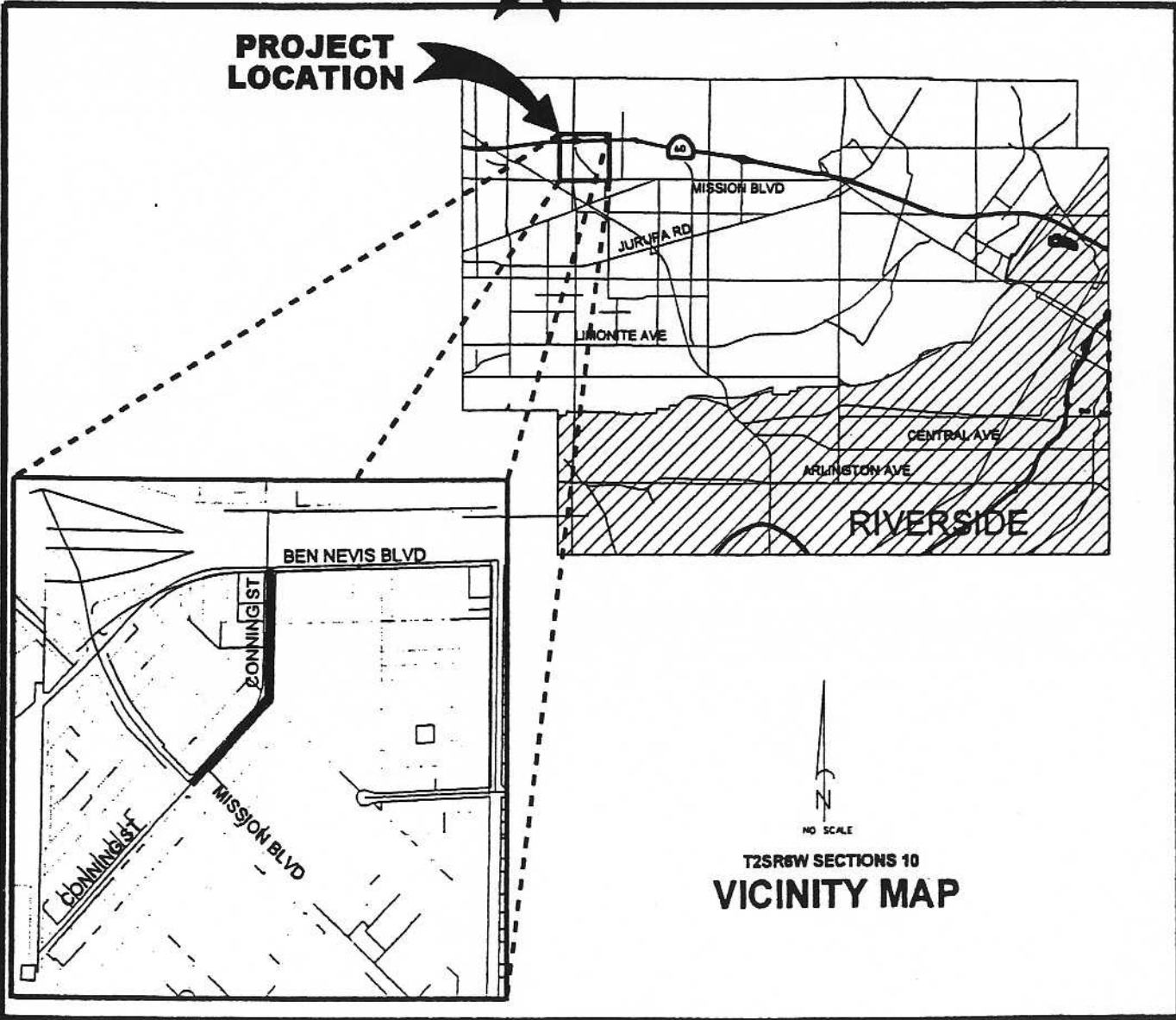
