SUBJECT: Notice of Completion – Reconstruction of Ramon Road with Portland Cement Concrete paving, from Varner Road to Interstate 10 East-Bound Ramp Terminal, in Thousand Palms area.

RECOMMENDED MOTION: That the Board execute and file the attached “Notice of Completion”

BACKGROUND: By Minute Order 3.19 of January 31, 2006, the Board entered into an agreement with Griffith Company of Santa Fe Springs, CA for the reconstruction of Ramon Road with Portland Cement Concrete paving, from Varner Road to Interstate 10 East-Bound Ramp Terminal, in Thousand Palms area of Riverside County. The authorized amount of the contract was \$2,092,769.00. The total amended contract amount (including quantity adjustments) is \$2,259,903.23, which is 8.0% more than the originally authorized amount.

This work was completed in conformance with the plans and specifications on May 22, 2006. The work was inspected by the Construction Engineering Section of the Transportation Department. Work Order B1-0671.

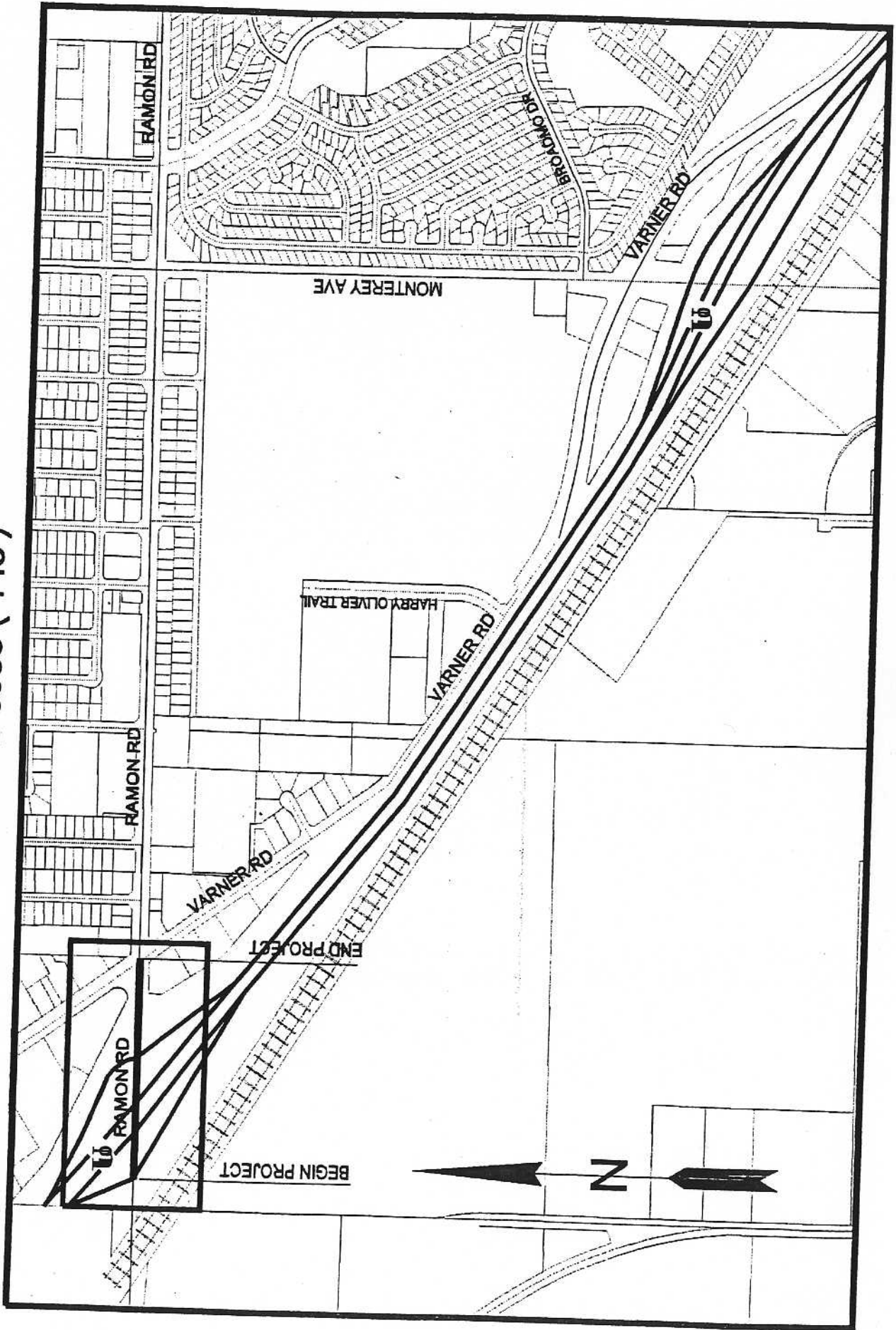
