SUBJECT: Notice of Intention to Change the Name of a portion of Weirick Road to Dos Lagos Drive, in the Corona area, Second Supervisorial District.

RECOMMENDED MOTION: Adopt Resolution No. 2007-007, Notice of Intention to Change the Name of a portion of Weirick Road to Dos Lagos Drive, lying between Interstate 15 and Temescal Canyon Road, contingent upon the freeway signs being changed to reflect the new street name.

BACKGROUND: SE Corporation has requested this name change to coincide with the Dos Lagos development being built in the area. The Dos Lagos development lies east of Interstate 15 and northerly of this portion of Weirick Road in the City of Corona. The City limits in this area is the centerline of current Weirick Road. This name change only affects the portion of Weirick Road lying in the unincorporated territory of the County of Riverside. On January 17, 2007, the City of Corona approved a Resolution changing the name of their portion of Weirick Road lying within the City limits.

Weirick Road was named to honor former Riverside County First District Supervisor, Arthur Weirick. Arthur Weirick served as the First District Supervisor from October 1946 to January 1949. The Historical Commission has reviewed this proposed name change and their position is neutral. Jean Larson, daughter of late Arthur Weirick, has submitted a letter in support of the name change (see attached). The adjacent property owners have been notified and no objections have been received.

The applicant, SE Corporation, has confirmed that they will pay the costs associated with changing the freeway signs to reflect this name change. See attached letters from SE Corporation and Caltrans regarding the freeway signs.

This is in response to your letter requesting information regarding a proposed name change of Weirick Road to Dos Lagos Drive east of I-15 in Riverside County.

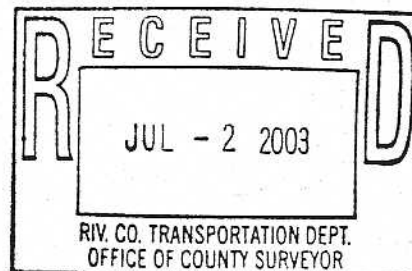
There are numerous signs along Interstate 15 that will require replacement if the name change is approved. These signs are both ground mounted and overhead. The Department can, at the expense of the requestor, replace these signs or the County can replace these signs under an encroachment permit. The cost to replace the ground-mounted signs is approximately \$7,500, excluding labor. The overhead signs are estimate to be approximately \$3,500, excluding labor. However, the cost may fluctuate significantly due to the need to upgrade the existing sign (truss) structure if necessary. Additional costs associated with this modification will be the associated hardware and any necessary lane closures.

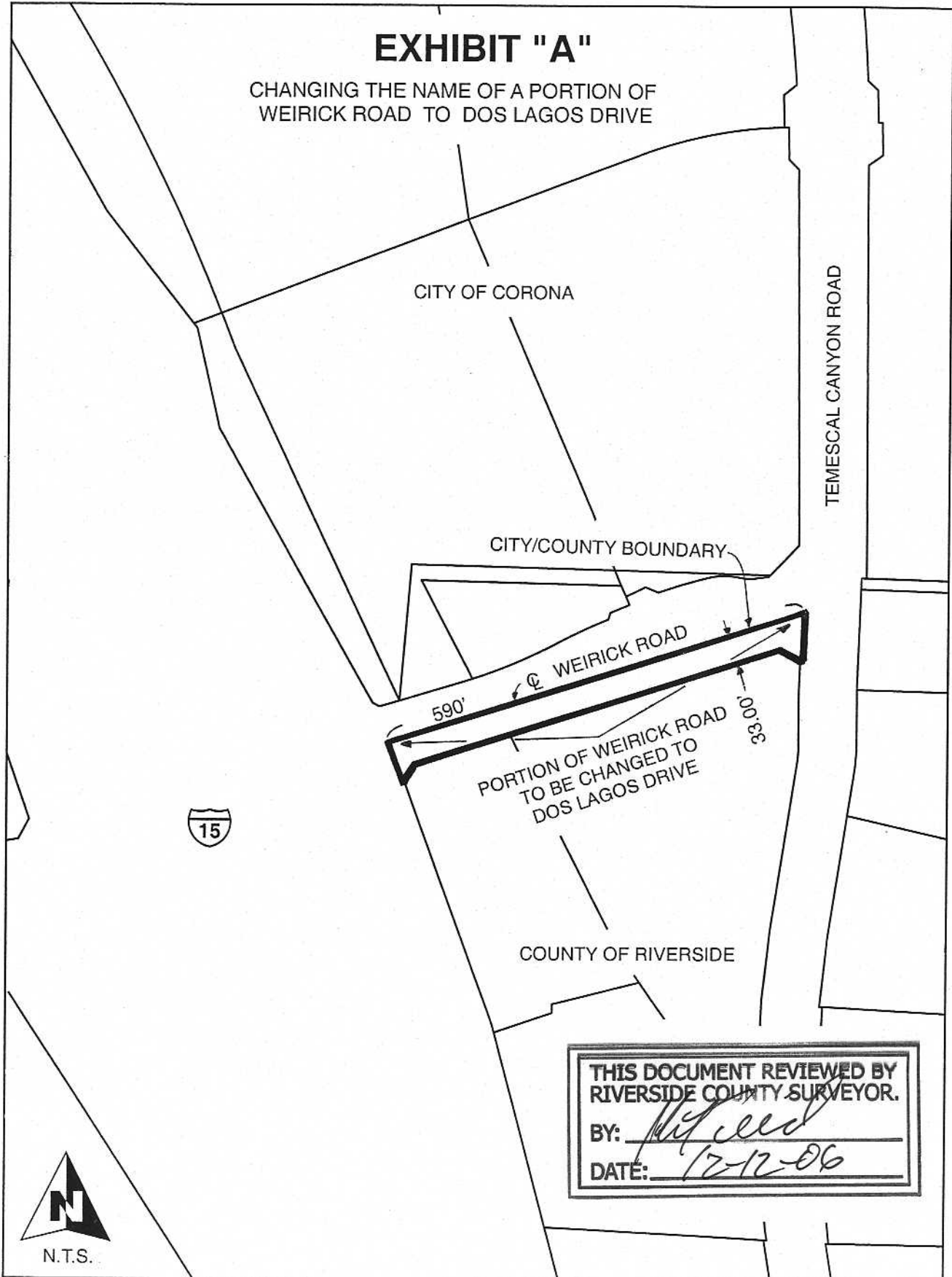

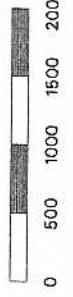
