**SUBJECT: HOUSING AND URBAN DEVELOPMENT RENEWAL GRANT AGREEMENT—  
U.S. VETERANS INITIATIVE**

**RECOMMENDED MOTION:** That the Board of Supervisors ratify and:

1. Authorize the Chairman of the Board to sign the attached Grant Agreement between Riverside County Department of Public Social Services (DPSS) and the U.S. Department of Housing and Urban Development (HUD) for a Supportive Services Only (SSO) Grant for \$249,900 for the period of October 1, 2006 through September 30, 2007;
2. Authorize the Chairman of the Board to sign the attached Contract, HU 3272-00, between DPSS and U.S. Veterans Initiative;
3. Authorize the Purchasing Agent to sign any ministerial amendments with U.S. Veterans Initiative, not to exceed the maximum amount of the Grant Agreement (\$249,900) ; and
4. Authorize the Director of DPSS to administer the agreement with U.S. Veterans Initiative.

**BACKGROUND:**

On June 7, 2005, (Agenda Item 3.60), your Honorable Board authorized DPSS to submit an application for Homeless Assistance funds to the U.S. Department of Housing and Urban Development, which included renewal funding for "Veterans in Progress" Supportive Housing Program operated through a contract between U.S. Veterans Initiative to provide supportive services only to homeless veterans.

The previous grant ended on September 30, 2006. HUD executed the attached renewal grant agreement on December 20, 2006, which we are forwarding to your Board for approval. U.S. Veterans Initiative's annual goal is to serve 50 homeless veterans annually. U.S. Veterans Initiative surpassed its annual goal and served 166 individuals during its previous three-year project and will continue its goal to serve 50 individuals per year under the attached renewal grant.
