**SUBJECT:** Notice of Intention to Change the Name of Chase School Road to Cook Street, in the Thousand Palms area, Fourth Supervisorial District.

**RECOMMENDED MOTION:** Adopt Resolution No. 2007-025, Notice of Intention to Change the Name of Chase School Road to Cook Street.

**BACKGROUND:** This change is at the request of a property owner who feels that the street name change from Chase School Road to Cook Street will aid the public and the emergency response system in the area to utilize Interstate 10 directional signage when seeking direction north of Interstate 10. The adjacent property owners have been notified of the proposed name change and the Transportation Department has not received any letters in opposition. Seven (7) letters were sent and four (4) responded in favor of the name change. Three (3) property owners did not respond.

The Historic Preservation Office was contacted and they have no objection to the street name change.

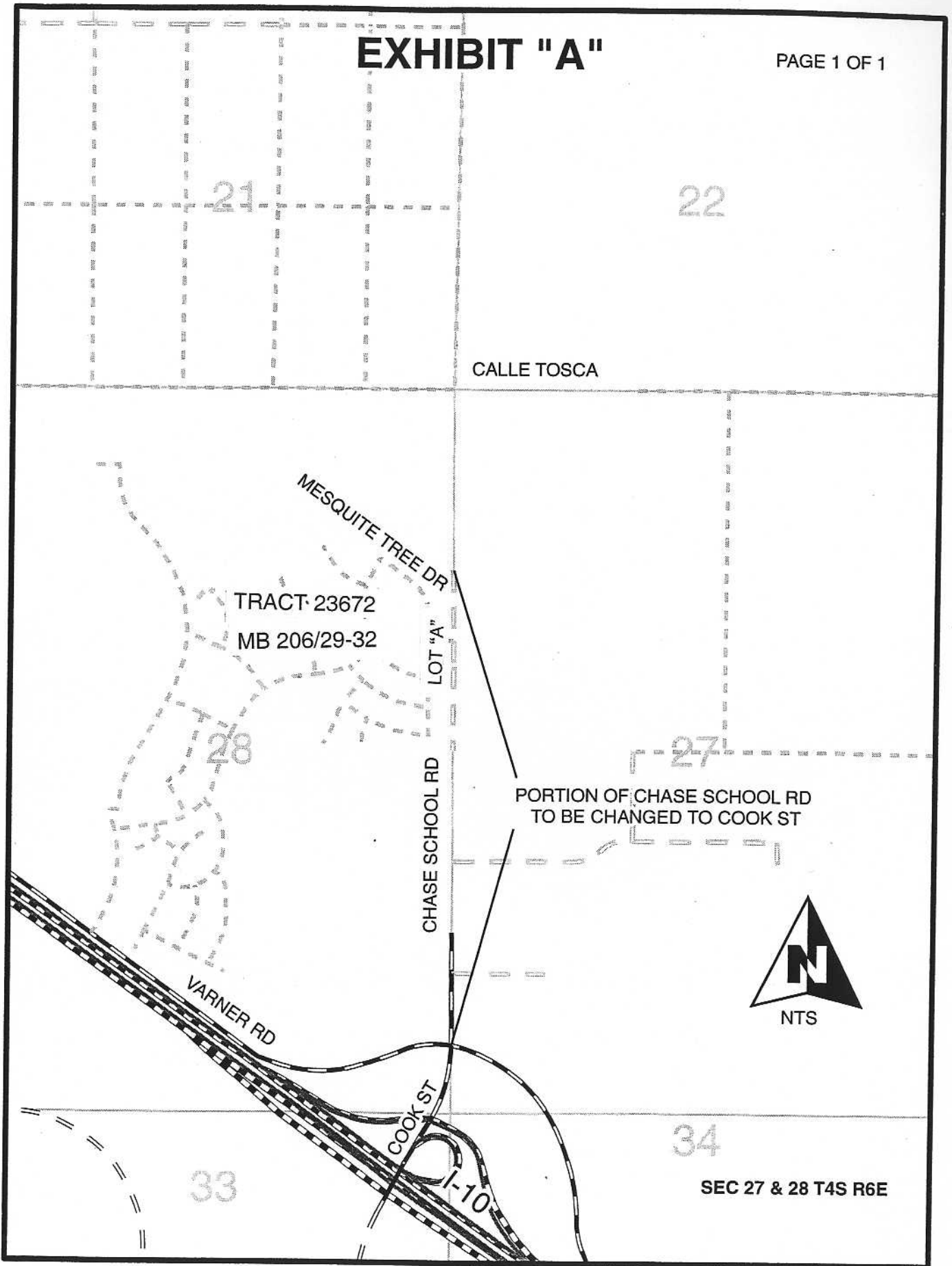
